

# Think Simplicity Direct SMS Privacy Policy

## 1. Introduction

Think Simplicity, Inc. (“we,” “our,” or “us”) is committed to protecting the privacy of our users and customers. This SMS Privacy Policy outlines how we collect, use, and safeguard your personal information when you sign up for our SMS notifications or marketing messages. By subscribing to our SMS services, you agree to the terms of this policy.

## 2. Information We Collect

- **Correction:** Request corrections to your personal information if it is inaccurate or incomplete.
- **Deletion:** Request the deletion of your personal information, subject to certain legal obligations.
